Eligibility:

The Energy Retrofit and New Construction Program rebates are available to any MID industrial, commercial, or agricultural customer. Rebates will only be issued for projects that show an overall wattage reduction as determined by a District Energy Services representative. The maximum rebate is \$150,000 per year, per customer and will not exceed 50% of the project's cost (equipment plus labor). Qualifying accounts for the Retrofit Program must be active and show previous energy use.

How to Apply:

1. Submit this application with project energy savings calculations and an estimate of project costs to MID (P.O. Box 2288, Merced, CA 95344-0288).
2. MID will contact you to schedule a pre-inspection visit. MID will notify you of your approval for rebate.
3. Notify MID of the project completion and schedule an inspection visit.
4. At the time of inspection we will require an original or legible copy of your PAID IN FULL itemized receipt.
5. Project MUST be completed within 90 days of submitting this application for rebate.

The Merced Irrigation District reserves the right to request specific manufacturer specifications and/or data. MID also reserves the right to periodically review and make changes to the program standards and requirements without prior notice. Payment by MID of any rebate does not imply endorsement or approval of any individual equipment manufacturer or supplier. Equipment performance and efficiency shall be the responsibility of the rebate recipient.

2007-2008 MID COMMERCIAL CONSERVATION INCENTIVE PROGRAM

Merced Irrigation District is interested in promoting conservation for electric usage. In order to encourage the investment required to reduce electric demand and kWh consumption, MID proposes the following:

- Customer to evaluate the usage of all equipment that is in operation for methods to reduce energy.
- Customer to identify specific conservation that will produce long term results that are not fuel switching or removal of equipment without replacement.
- Customer's engineer to write up the proposal with computations on the net kWh savings and demand reduction.
- Customer will then send this application form, and a proposal with cost estimates of the equipment to accomplish the conservation to MID for review and approval.

MID will consider payment for conservation based on total kWh saved over one year at a rate of \$0.07 or 50% of the installation cost, whichever is lowest, up to \$150,000 per year. MID will budget an amount each year for the projects and will approve projects up to the limit of the budget.

This program is subject to change as determined by the Board of Directors of the Merced Irrigation District.
