

HOW TO APPLY:

1. Submit this application with project energy savings calculations and an estimate of project costs to:

2. An Authorized MID Representative will notify you of your approval for rebate.
3. Notify MID's Public Benefit Manager of the project completion and schedule an inspection visit by calling 209-354-2819.
4. At the time of inspection MID will require an original or legible, PAID IN FULL itemized receipt.
5. Project must be completed within 90 days of submitting this application for rebate.

Merced Irrigation District reserves the right to request specific manufacturer specifications and/or data. MID also reserves the right to periodically review and make changes to the program standards and requirements without prior notice. Payment by MID of any rebate does not imply endorsement or approval of any individual equipment manufacturer or supplier. Equipment performance and efficiency shall be the responsibility of the rebate recipient.

The Merced Irrigation District, hereinafter MID, offers a maximum rebate of \$150,000 per year, per customer and will not exceed 60% of the project's cost (equipment plus labor). New Construction Projects must be inspected and require approval by an authorized MID representative to ensure availability of funds prior to issuance of rebate. To ensure availability of funds prior to construction please call our Public Benefits Department at 209-354-2819. To schedule an inspection once project is complete please call 209-354-2819.

Upon signing this agreement, customer understands and agrees to the following:

MID may discontinue this rebate program at any time, and it is limited to the availability of funds. MID disclaims any warranty, whether expressed or implied, regarding the lighting equipment installed, or for any materials or labor associated with its installation, maintenance, repair, or any energy savings associated with its use.

MID offers its Commercial Industrial New Construction Program to any MID industrial, commercial or agricultural customer currently receiving electric service from the District. Rebates will only be issued for projects that show an overall wattage reduction as determined and approved by an MID representative.

I understand the above and certify that I am a customer of Merced Irrigation District and the ***above mentioned products*** will be installed at the location indicated above and that ***sales transactions and product installation verification*** will be provided to MID prior to rebate issuance.

By signing this application, customer agrees to maintain service with MID for five (5) years from the date of rebate issuance. Upon receipt of rebate, any active or non-active Electric Service Agreements between above said customer and MID will automatically extend the service agreement by five (5) years beginning with the date of rebate issuance.
